Co-ordinate the monthly and annual SHEQ reporting returns to the Senior Health and Safety Manager and ensure that corrective actions are implemented for any under performance. Provide a high quality, customer focused service that is responsive to customer needs. Take responsibility for the co-ordination and compliance for all audits. Planning & undertaking audits, working with auditors to identify internal controls, working with senior management to provide corrective actions for any non-conformity and closing out the audit. Establish and maintain effective working relationships with peer groups and key internal stakeholders. Role holder will future proof themselves and MDS through a robust Continuous Professional Development plan Attend management forums to discuss SHEQ performance including progress updates and planned/future implementations/developments.
